



## **BOZEMAN COST OF LIVING 9% ABOVE NATIONAL AVERAGE**

Bozeman, Montana, November, 2008 – Prospera Business Network released today its Bozeman Cost of Living Report for the third quarter of 2008. According to the report (based on the ACCRA Cost of Living Index), the after tax cost of living for a professional/managerial household in the city of Bozeman registered at 9 percent above the national average. The other two Montana cities in the study, Missoula and Kalispell, both ranked above the national average at 6 percent and 3.1 percent respectively. Bozeman's composite score of 9 percent above the national average compares to the previous quarter's score of 7.5 percent above the national average.

The *ACCRA Cost of Living Index* composite score is based on components including housing, utilities, grocery, transportation, health care and miscellaneous goods. "Once again, Bozeman's cost of living is driven up this quarter by the cost of housing in Bozeman which is 17.8 percent above the national average," said Prospera CEO Bob Hietala. In the previous quarter, Bozeman's housing cost was 18 percent above the national average. Bozeman's cost of living is comparable to Bellingham, WA (12.3 percent above the average). Bozeman continues to have the highest cost of living (and cost of housing) in Montana. The other two Montana cities in the study, Missoula and Kalispell, recorded housing costs at 2.4 percent below and 1.2 percent above the national average, respectively.

The *ACCRA Cost of Living Index* measures regional differences in the cost of consumer goods and services, excluding taxes and non-consumer expenditures, for professional and managerial households in the top income quintile. It is based on more than 50,000 prices covering almost 60 different items for which prices are collected quarterly by participating urban areas. The *Index* is compiled and published quarterly by C2ER, The Council for Community and Economic Research. Prospera Business Network collects and reports data for the city of Bozeman each quarter.

Items on which the Index is based have been carefully chosen to reflect the different categories of consumer expenditures. Weights assigned to relative costs are based on government survey data on expenditure patterns for mid-management households. All items are priced in each place at a specified time and according to standardized specifications. The *ACCRA Cost of Living Index* is the most reliable source of city-to-city comparisons of a key consumer costs available anywhere.
